His instruction covers a wide range of topics, including trial procedures, developing case theories and themes, developing and delivering opening statements and closing arguments, how to effectively examine witnesses, and how to utilize the rules of evidence.

He received his bachelor's degree in business administration from Midwestern State University and his law degree from SMU Dedman School of Law.
